Air conditioner rebates up to \$200\* and heat pump rebates up to \$1,000\* with the purchase of a new natural gas piece of equipment. Financing of up to \$25,000\* also available.

Upgrade to qualifying equipment and you may be eligible for rebates, including up to a \$1,000\* rebate for a high efficiency heat pump (see chart below) when you purchase a qualifying natural gas furnace, boiler or water heater, as well as incentives from New Jersey Natural Gas (NJNG), including 0%\* APR financing through NJNG's On-Bill Repayment Program (OBRP).
